### **Context**

The children at Bunbury Aldersey Church of England Primary and Nursery school are taught in single aged classes from Reception. The school is open for children from 8:45am until 3:15pm each school day. After school clubs are provided throughout the year. These are either run by school staff or outside providers. The school has extended care provision on site which runs from 7.30am - 8.45am and then 3.15pm - 6.00pm.
